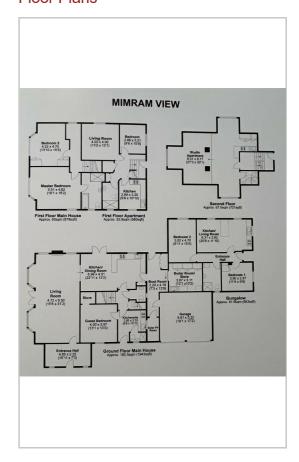
solar panels

With solar panels already installed, this home offers significant savings on energy bills by reducing reliance on grid power. This cost savings makes the home more energy-efficient and affordable to maintain.

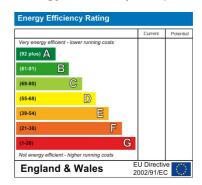
Area Map
